IMPORTANT TAX DEDUCTION FOR EQUIPMENT

IRS SECTION 179 AND BONUS DEPRECIATION

Thanks to IRS Section 179 and bonus depreciation guidelines of the Federal Tax code, businesses (large or small) investing in new equipment may be eligible to deduct 100% of the purchase price of the equipment purchased in that current tax year. IRS Section 179 allows qualifying equipment of up to \$1,050,000 annually to be fully deducted in the current tax year as opposed to spreading it out over the life of the equipment. In addition, bonus depreciation is allowed for amounts in excess of the Section 179 limit so that 100% of any new equipment purchases can be deducted in that tax year. **Please contact your tax advisor to see if your business qualifies for the deduction.**

Why Act Now?

- Significant tax relief for businesses investing in qualifying equipment
- The Section 179 and bonus
 depreciation deductions can be taken
 on qualified equipment that is either
 financed or purchased and put into
 service between September 27, 2017
 and December 31, 2022. (see page 2

- These favorable tax treatments
 may change as a result of the 2020
 election so we encourage all of our
 customers to act quickly to take
 advantage of these deductions.



2021 SECTION 179 EXAMPLE CALCULATION

Equipment Purchases:

First Year Write Off: \$1,050,000

(\$1,000,000 = maximum in 2018 and adjusted annually)

100% Bonus First Year Depreciation: \$100,000

(updated to 100% via Tax Cuts and Jobs Act)

Normal First Year Depreciation: \$0

(20% in each of 5 years on remaining amount)

Total First Year Deduction: \$1,150,000

(\$1,050,000 + 100,000 + 0)

Cash Savings: \$241,500

(\$1,150,000 x 21% corporate tax rate)

Equipment cost after Tax:

(assuming a 21% corporate tax bracket) \$908,500
